Age	Should have been born on or after, 1 <sup>st</sup> Nov 1992 for General candidates. Should have been born on or after, 1 <sup>st</sup> Nov 1989 for Female/ SC/ ST/ Transgender/ PwD candidates.
Emoluments	The selected candidates will be provisionally placed at starting Basic Salary of Rs. 10,500/- pm with CTC of Rs. 4.44 LPA and will be designated as <b>Senior O&amp;M Associate – I</b> (GH-D1 grade).
